In Recognition of H.H. Efforts in Improving the Lives of Patients Locally and Regionally,

Hamdan bin Rashid Named Personality of the Year by Sultan bin Khalifa Thalassemia Award

His Highness Sheikh Hamdan bin Rashid Al Maktoum, Deputy Ruler of Dubai, Minister of Finance, and the patron of both Hamdan bin Rashid Award for Medical Sciences and Hamdan bin Rashid Al Maktoum Award for Distinguished Academic Performance, was named Personality of the Year by the Sultan bin Khalifa Al Nahyan International Thalassemia Award in its first edition 2011-2013.

Naming H.H. Sheikh Hamdan bin Rashid Al Maktoum comes in recognition of the efforts exerted by His Highness in improving the lives of thalassemia patients locally and regionally, and H.H's support by the establishment of the first center in the region and the Middle East for the treatment of thalassemia patients under Dubai Health Authority in 1989. Under the instructions of His Highness, the largest center for thalassemia in the Arab World has been built and was inaugurated by his Highness in 1995. H. H. also ordered the development of many educational programs that have limited the spread of the disease in the UAE.

In fact Hamdan bin Rashid Award for Medical Sciences has had a significant impact on enriching scientific research that contributed to the development of the thalassemia treat-

In the period between 20th and 23rd of October, Abu Dhabi hosts Thalassemia International Federation World Congress (TIF 2013), with the participation of more than 2000 doctors and specialists, as well as 15th TIF International Conference for Parents & Patients.

The biennial TIF Conference discusses the increase rate in the prevalence of thalassemia and blood disorders in

the Middle East and around the world. It is estimated that about 7 percent of the world's population carry the genes responsible for hemoglobin disorders while 500 thousand newborn children every year around the world suffer from severe genetic blood disorders. Abu Dhabi was nominated to host the TIF Conference in recognition of the tremendous efforts made by Sultan bin Khalifa Al Nahyan Humanitarian & Scientific Foundation, and the achievements made by the UAE 's medical community in raising awareness of this disease.

According to Sheikh Zayed bin Sultan bin Khalifa Al Nahyan, Chairman of Sultan bin Khalifa Al Nahyan Humanitarian & Scientific Foundation, thalassemia is a source of great concern in the Middle East because of the large increase in the number of injuries over the past few years. However, Sultan bin Khalifa Foundation estimates that one out of every 12 people in the UAE carry the disease.

The Award received 300 nomination to compete in 6 international categories and 14 local categories, representing individuals (doctors, nurses, social networks, researchers, supporters and students) and medical organizations and institutes for thalassemia cent-

The winners from all over the world who have made outstanding achievements in the fields of medical research, health services and innovation in various medical specialties related to thalassemia receive cash and testimonial prizes.

Mr. Panos Englezos, TIF President stated that thalassemia is one of the most common genetic and blood disorders diseases known to mankind, and the number of carriers of

the disease in the world hits to more than 490 millions.

"In the absence of comprehensive prevention programs for thalassemia, children infected by the disease continue to be born, the thing which imposes pressure on the medical, economic and social resources of many countries." He added. He stated that the conference

aims at providing the latest information and developments for patients and their families, and sharing experiences on the best practices followed for dealing with this disease by doctors, specialists, scientists, researchers and other health professionals working in the field of basic patients care.

There were great achievements by the region in dealing with thalassemia patients in the United Arab Emirates, Iran, Lebanon, Bahrain and Saudi Arabia, which are perfect examples of other countries to be followed.

Free treatment for thalassemia patients is available in the UAE as it is a hereditary disease with a 25% increase in infection possibility when the parents are carriers of the dis-

Thalassemia occurs when there is a defect in the gene that controls the production of proteins in hemoglobin; the thing which can lead to anemia. (WAM)

Hamdan Award Publishes 16th Cycle Publications

Hamdan bin Rashid Al Maktoum Award for Distinguished Academic Performance published the set of publications related to its 16th Cycle. This set included the Harvest Book of 15th Cycle, the General Introductory Guide, and the Explanatory Guides of Hamdan Award Criteria and Categories in both Arabic and English, as well as posters covering the Award scope of competition and categories.

One of the posters was allocated for all competitions in both Arabic and English, whereas seven other posters covered national competitions in general education and national competitions in higher education in both Arabic and English, Education-Supporting Organizations Award in both Arabic and English, GCC competitions, and Arab Educational Research Award.

The Award also published the book of Best Practices in the 15th Cycle, which probed the practices of a number of winners at the 15th Cycle which including various categories. In application to its media

plans in promoting the culture of educational research, supporting and encouraging researchers, Hamdan Award published two research papers, the winners of Best Applied Educational Research at the local level: the first one is entitled "Effectiveness of Training Program for Development of Reading Music by Kindergarten Students" by researcher Hala Salah al-Din Abdul Hameed of the New Generation Kindergarten, Abu Dhabi.

While the second research is entitled "Studying Factors behind Sleeping During Classes Phenomenon and Effective Educational Treatment Strategy" by researcher Nasser Hamed Moosa Al Hamadna of Abu Dhabi School for Secondary Education.

Moreover, the Award published a book entitled "Reference Guide in Spotting Talented Students" by Dr. Moosa Al Nabhan, Vice Dean of the Faculty of Post-Graduate Studies in the Arabian Gulf University, commissioned by the Award wherein the Award aims at

promoting and developing programs of giftedness care.

The guide, which had been prepared over one year, shall be deemed as the first reference in Arabic in the field of spotting talented students since there is no book in Arabic fully designated to tackling the issues of discovering talented; rather there is information available within one or maximum two chapters in some books. Therefore, it was very important to initiate a comprehensive reference for gifted people.

The book was adjudicated by experts in talent, who, in turn, stated their adoption of it. It was also adopted as a reference book by the Arabian Gulf University to be taught at Gifted Education Diploma, the 4th batch, within the course of measurement and identification of talented people.

Hamdan bin Rashid Al Maktoum Award for Distinguished Academic Performance has chosen 20 teachers and psychologists from different educational zones in the UAE to constitute the 4th batch of candidates to the Gifted Education Diploma (GED), which is implemented by the Award in collaboration with the Ministry of Education (MOE) and Arabian Gulf University (AGU).
Out of the 105 applications

submitted to the 4th batch of GED program which is implemented in line with the objectives of the National Plan for Nurturing the Gifted, only 42 applications were qualified to the personal interview.

An introductory meeting for participants in GED has been organized by Hamdan bin Rashid Al Maktoum Award for Distinguished Academic Performance at the UNESCO Regional Centre for Educational Planning in the University City in Sharjah.

Mr. Sulaiman Abdul Khaliq, Chief Executive Director of the Award stated that this quality program has continued accepting candidates for the fourth year to study in GED

program which is intended to meet the needs of the National Plan for Nurturing the Gifted of competencies specialized in spotting and nurturing gifted students.

He added that the Award is committed to a strategic partnership with MOE and AGU in this quality program, which is the first of its kind as it is the first program specialized in the education of giftedness to be applied in the UAE in cooperation with AGU and MOE for teaching talented students. 

Dr. Jamal Al Muhairi, Secretary-General of Hamdan bin Rashid Al Maktoum Award for Distinguished Academic Performance announced increasing the shares of Distinguished Student at the 16th Cycle, pointing out that this step keeps pace with the developments experienced by educational field in the UAE, and comes in line with the increase in the number of teachers, students and schools, private schools in particular.

In an interview with «Al Tamayoz News» magazine, he explained that shares has been re- scheduled and updated of in proportion to the current reality of the participations, and that such increase included all educational zones.

He reported that the current Cycle saw minor amendments in some criteria including various categories of the competition, attributing reasons thereof to feedback received from the education field, observations of clients and adjudicators, and changes in grading some standards or repetition or typographical errors avoided by current amendments, noting that such amendments aimed at facilitating things on participants.

Dr. Al Muhairi cited that the conditions for participation in competitions of Distinguished Student have been amended so that the students of first and second primary grades shall not be eligible to participate in competitions of Distinguished Student; participations begin from the third grade. He said that the reason for this amendment is due to a lack of participations and the difficulty of reflecting excellence at this stage wherein the student depends on the parents to highlight his/ her excellence.

He pointed out that the applicant is required to submit attachments for the last three years excluding the year of application as some applicants find receiving certificates in the middle of the school year difficult; the thing which impede the work of the central adjudication committees checking and registering attachments.

The Secretary-General of the Award noted the emiratization policy of adjudication committees adopted by the Award, pointing to seeking to inlaying committees with various institutions and government departments, as well as federal institutions interested in the quality and educational excellence sector.

Dr. Al Muhairi stressed updating the adjudication list to keep pace with developments in the field of education, pointing to the Adjudication Forum to be held on the 8th of October, aiming at raising the level of adjudication processes, improving the performance of the Award adjudicators both within the UAE and abroad, bringing viewpoints even closer and standardizing adjudication practices and concepts among the members of the jury.

He added that the among objectives of the Forum training adjudicators on modern models of the evaluation of Excellence in Government Performance criteria, and presenting the remarks and updates of the new cycle in regards to competition and adjudication, as well as the direct communication and formation of climates suitable to support the relationship between the Award and its adjudicator at all levels. He referred that the 8th Best Practices Seminar to be held on the 9th of October, which aims at increasing the awareness of academic community towards distinguished academic practices; spreading and transmitting knowledge, expertise, and distinguished experience and deepening excellence culture by means of displaying and documenting



the best experiences according to the standards of the academic performance, honoring distinguished academic achievements besides their authors. It also aims at documenting and defining distinguished academic practices; spreading and disseminating the culture of excellence in academic performance and introducing the winners' efforts and distinguished innovations as well as crowning of winners' effort and motivating them to proceed on the excellence way and encouraging distinguished people to apply for the Award. Answering a question about the extent to which the Award utilized the spread of social networking media and modern techniques in the identification of others' experiences and bridging the distance and time gaps to reach the optimal programs and methods for the application of practices of quality education, Dr. Muhairi cited that the Award has launched services the Award clients and categories including advisory

services, guiding workshops and courses specialized in educational excellence for all standards.

tional zones as positive in increasing the number and quality of participations; the thing which with eventually increase in the number of winners.

Dr. Al Muhairi estimates increased number of applications on Arab Educational Research based on the number of inquiries received and still being received by the Award, expressing his anxiety that none of the research involved in the previous cycle was qualified to the rank of winning.

In his answer to the question of his assessment of the last cycle participation, Dr. Al Muhairi said that last year files were characterized by seriousness and excellence; the thing which was noticed clearly and evidently from the high percentage of winners compared to applicants. This suggests that applicants further understood and comprehended Award's criteria, pointing out that there are no intentions

now to add new categories to the Award.

tices in support of the teachers. The Secretary-General of the Award revealed a project of preparing a list containing the creativity characteristics of gifted students aiming at spotting and discovering talented students in the UAE.

Concerning Gifted Education Diploma (GED), Dr. Al Muhairi pointed out that the 4th batch of the program, which includes 20 teachers had finished the theoretical part of the program; while the teachers as currently working on exciting the practical part of the program in the schools in application of what they have already studied in the theoretical part. He stated that GED students had faces a «discharge' problem, so the Award worked in coordination with the Ministry of Education (MOA) and AGU to overcome this problem; thus, most of the GED period becomes in summer, and the Award also communicated

with school administrations and educational zones to facilitate the GED students task. Dr. Al Muhairi stressed that the AGU in Bahrain formally requested adopting the book entitled «Reference Guide in Spotting Talented Students», which the Award commissioned Dr. Moosa Al Nabhan. Vice Dean of the Faculty of Post-Graduate Studies in AGU to prepare.

He described the book as the first reference in Arabic in the field of spotting talented students, pointing out that there is no book in Arabic fully designated to tackling the issues of discovering talented; rather there is information available within one or maximum two chapters in some books, noting that what distinguishes this book from other Arab and foreign books whose titles refer to spotting and identification of talented students is that it ensures a sufficient background

to help in the formation of a detailed systematic and training culture in the process of discovering talents.

He referred to the Award participation and presenting practical experiments in the 20th Biennial Conference of the World Council for Gifted and Talented Children (WCGTC) Kentucky, USA, and the Conference of the European Association for Research on Learning and Instruction (EARLI) in Munich, Germany, and the 3rd International Conference on Talent Development & Excellence in Turkey, with the objective of sharing experience in the field of talent care and developing the national cadre therein.

Dr. Al Muhairi admired the success of the spring and summer programs for gifted students, noting that the students who joined these programs experienced training courses in psychological, social and

scientific skills.

He stated that among the positive aspects of the summer program this year is that it was carried out in the IT institutes where the potential and specialists were available; the thing which was had positive impact on the students.

Dr. Al Muhairi reported that the number of beneficiaries of enrichment programs in the spring reached 25 applicants, while the total number of enrolled students amounted to 33; while in the summer program, the number of applicants was 60, while the enrolled students was 48.

He added that the Award is currently preparing a winter camp for talented students; and have just finished preparations of two programs: one of them is dedicated to develop the psychological and social skills of talented students and the other one is to guide their parents.
